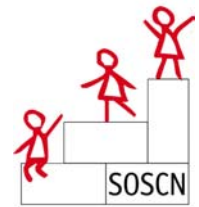

Scottish Government & COSLA - Early Years & Early Intervention Policy Discussion

Despite only having 4 weeks to respond to this consultation which was launched on 18th March, SOSCN received more than 20 responses from the sector using a "Standard Response" form- these have all been submitted to Government along with our own detailed response. SOSCN also attended a consultation event run by the Government and COSLA where we again represented our concerns and issues regarding the document, as it currently stands.

The next stage of the consultation process will be the setting up of various "task groups", each of which will look at specific issues and tasks relating to the policy. Task groups can be contacted by stakeholders to share concerns or provide input. SOSCN will be involved in one of these groups- we shall update when further information is available.
